Earlier in his career, he acted as co-counsel in *Vriend v. Alberta*, the first successful case in support of LGBTQ2+ rights before the Supreme Court of Canada.

Doug currently serves as President of the Stollery Charitable Foundation. He has recently completed his term as Chancellor, Chair of the Senate, and member of the Board of Governors of the University of Alberta. In the past, he has served as President of the Alberta Branch of the Canadian Bar Association, as a sessional lecturer at the University of Alberta Faculty of Law, and as a director of a number of non-profit organizations including CARE Canada, the Stephen Lewis Foundation and Grant MacEwan College.

Doug is a member of the Order of Canada, the Alberta Order of Excellence, and a fellow of the Canadian College of Construction Lawyers. He is the recipient of a number of awards and accolades including honourary doctorate degrees from the University of Alberta and MacEwan University, the Distinguished Alumni Award from the University of Alberta, the Distinguished Citizen Award from MacEwan University, the Canadian General Counsel Lifetime Achievement Award, and the Queen Elizabeth II Diamond Jubilee Medal.
